Q Shelter Members enjoy discounted access to all our training and events. If you opt for organisational membership, this discount is applied to all your staff. In fact, this year an organisation became a member because the discounts they would receive for their team to attend a single training program made membership an investment that paid immediate returns.

Q Shelter's membership fees are quite modest, compared to others in the sector, and we feel the value proposition is strong for organisations of all sizes.

- Small Community Organisation (turn-over under \$250k), \$150 per annum
- Large Community Organisation (turn-over above \$250k), \$250 per annum
- For Profit, Statutory, and Government Bodies, \$550 per annum
- Individual membership, \$30 per annum
- Student/Concession membership, \$10 per annum

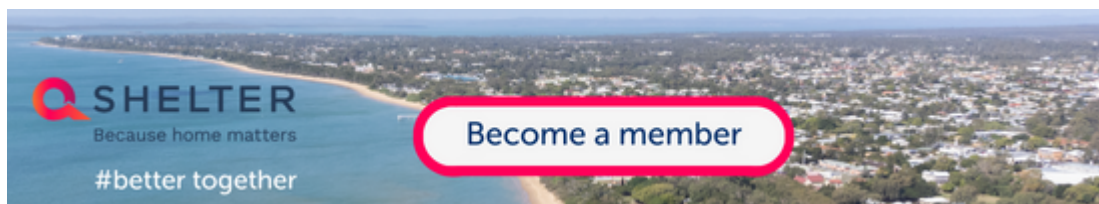
