Q Shelter believes in working collaboratively to solve persistent challenges like homelessness.

We are confident that Q Shelter played a substantial role in defining and amplifying pragmatic solutions, forwardthinking policy and appropriate investment mandates. We are collaborating with community and private sector peak organisations to progress high-impact projects. The level of convergence of opinion about solutions is encouraging.

Across our organisations, we agree on so much. This is reflected in the contributions to the Queensland Housing Summit and across many other engagement platforms to progress important reforms impacting homelessness responses and housing supply.

Since 2018, Q Shelter's offering expanded across our strategic outcomes of influence and sector capacity. As we have reached a record number of attendees at events, we strive to ensure that this engagement results in timely, workable advice to government about future solutions.

Highlights in the past year include a leading role in the Queensland Housing Summit, expanding programs contributing to sector capacity, inception planning for a workforce project and improvements to our standing engagement mechanisms involving diverse stakeholder groups.

Our largest ever CEO and Leaders' Forum, in collaboration with the Housing and Homelessness Peaks' Partnership, reflected a broad housing and homelessness eco-system with an incredible diversity of backgrounds, capabilities and perspectives.

This is exactly what it will take to ensure every Queenslander has a home – working together collaboratively and with purpose!

Q Shelter works towards the health of the whole housing and homelessness system. We are working on policy settings and investment as far upstream as possible. We are determined to reduce the flow of people into homelessness, while also ensuring housing supply and diversity to meet all needs. Across 2022-23, Q Shelter has continued its work to transform our organisation through technology enablement, business process improvements, improved culture, staff engagement and development. For two consecutive years now, Q Shelter has achieved *'Best Workplace Award'* from The Voice Project. We are striving to sustain this result in the coming year, with continuous improvements as an employer through investing in the culture of the organisation and celebrating the many successes of the team.

We thank you all as our stakeholders. We also thank the Queensland State Government for their investment in our organisation. Our staff team have excelled, with their passion, commitment, and capability always apparent. We also thank the wider management committee for outstanding governance, and for their contribution to navigating complexity towards a strong and sustainable future for Q Shelter.

Highlights from 2022–2023

- Played a key role at the inaugural Queensland Housing Summit.
- Commenced the Community Housing Futures Program in partnership with the Queensland Government, Aboriginal and Torres Strait Islander Housing Queensland, and the Community Housing Industry Association, Queensland.
- Expanded the Regional Representatives Forum to 19 regions and two interest groups.
- Made submissions and attended two hearings for national inquiries into poverty and cost of living pressures.
- Tabled seven submissions on key policy and investment solutions including our annual Better Together statement, input to the Queensland Housing Summit, and a proposal to prevent community violence through intensive, high-quality, early life interventions. <u>Read more on p.8</u> >

- Expanded our learning and engagement events across the state with record registrations (6,000+) and satisfaction levels.
- Collaborated with the Real Estate Institute of Queensland, Safe Home Alliance, and the Department of Justice and Attorney General to expand learning resources on Domestic and Family Violence for private real estate agents.
- Launched the Kent Maddock Memorial Award for place-based alliances responding to housing need and homelessness.

Awarded The Voice Project 'Best Workplace Award' for the second consecutive year.



Looking ahead 2023–2024

Over the next year Q Shelter will:

- Contribute to a statewide housing plan.
- Collaborate with National Shelter and our other stakeholders to contribute to the National Housing and Homelessness Plan.
- Progress Community Housing Futures capacity-building activities to grow the supply of social and affordable housing.
- Implement a workforce wellbeing, attraction and retention program in collaboration with Homelessness Queensland and other peak bodies.
- Participate in the AHURI 2023 National Housing Conference as a major sponsor.
- Partner with the UQ Ventures Industry Challenge showcase to identify new and innovative ways to deliver housing supply.

- Continue to expand our learning and development offerings across the State.
- Continue delivering Service Integration initiatives.
- Strengthen the Regional Representatives Forum and the CEO and Leaders Forum as key policy development mechanisms.
- Advance practical solutions to building community support for housing diversity.
- Graduate a new cohort of peer leaders.
- Implement an environmental, social and governance (ESG) framework to measure our impact as a peak body.



Community Housing Futures Program



The Community Housing Futures Program was established in January 2023 to enhance the capability and capacity of Community Housing Organisations (CHOs) to increase social and affordable housing supply in Queensland.

The Program supports CHOs through grants for specialist business advisory services, access to capability and growth assessments, and training, tools, and resources aimed at supporting growth activities.

Aboriginal and Torres Strait Islander Housing Queensland, the Community Housing Industry Association Queensland, and Q Shelter are partnering with the Queensland Government to deliver the Program, with Q Shelter as the auspice body.

2022-2023 highlights

During this financial year, the Program:

- Established an Approved Professional Advisory Panel to provide professional advice on finance, business planning, property development, and risk management.
- Developed a grants program, supported by the Approved Professional Advisory Panel, to provide Community Housing Organisations with access to a range of professional services.
- Established an Industry Reference Group with 18 CHO representatives to provide input towards Program delivery.

- Engaged with the sector through regional visits to Brisbane, Gladstone, Townsville, Rockhampton, Biloela, and Mackay.
- Met with industry leaders and completed over 20 presentations to the sector about the Program (in-person and online).
- Appointed AHURI as evaluation partner to help measure the impact of the Program.

Looking ahead 2023-2024

Over the next year, the Program will:

- Conduct 30 growth-readiness and capacity assessments to provide valuable insights and guidance to CHOs.
- Distribute \$2.2 million of Professional Advisory Grants to CHOs.
- Consolidate existing sector-related tools and resources into a comprehensive directory.
- Develop new tools and resources based on feedback and identified needs within the sector.
- Promote collaborative, innovative, cross-sector relationships to advance the Community Housing sector across Queensland.

Influence

Working to influence solutions to housing need and homelessness

On behalf of the sector, Q Shelter broadened our engagement across all levels of government this year to advance key policy ideas and solutions to housing stress and homelessness. We met with 22 federal representatives, 48 state representatives, 16 mayors, and a range of senior departmental and ministerial staff.

Strategic engagement highlights:

Policy highlights:

- Expanded the Regional Representatives Forum to 19 regions and two interest groups.
- Grew the Queensland Housing and Homelessness Peaks' Partnership CEO and Leaders' Forum (over 230 attended in June 2023).
- Established a Community of Practice around the need for greater housing diversity with fourteen peak, industry and professional bodies including:
 - Property Council of Australia
 - Planning Institute of Australia (QLD)
 - Master Builders Queensland
 - CHIA Queensland
 - UDIA Queensland
 - Strata Community Association (QLD)
 - The Australian Institute of Architects (QLD)
 - Urbis
 - Studio THI
 - YIMBY Queensland
 - Articulous
 - Local Government Association of Queensland
 - SEQ Mayors
 - Q Shelter

- Published a comprehensive policy and investment framework, Better Together, in the lead up to the 2023 State Budget.
- Tabled seven submissions on issues that included inclusionary zoning (June 2023), Queensland's preparedness to host the 2032 Games (June 2023), stage two rental law reforms (May 2023), safety through violence prevention (January 2023), the rent freeze amendment bill (November 2022), and Queensland's Housing Summit (October 2022).
- Contributed to collective advocacy work that restored the Employment Remuneration Order supplementation payment.
- Saw the Queensland Government's land audit completed in May 2023 after our long-term advocacy on behalf of the sector for a strategic approach to land identification for all residential development (including social and affordable housing).

Policy wins that Q Shelter contributed to:

- Agreement from the Queensland State Government to host the inaugural Housing Summit.
- Expanded tenancy sustainment funding.
- Increased funding allocated for targeted Specialist Homelessness Services to address increased need (including for families).
- Increased Housing Investment Fund.
- Increased capital funding for social housing.

- Changes to machinery of government to achieve a single housing portfolio.
- A funded campaign to increase community understanding of the need for housing growth and diversity.
- Local Governments progressing housing action plans.
- A land audit identified land suitable for housing supply.
- Increased indexation for funded services.
- Early consideration of a housing legacy from Brisbane 2032.



We are always improving how we capture the sector's needs for training which has helped to progress events that are well received and well attended.





Service Integration

Facilitating system capacity for integrated, front-line responses to people with multiple needs who are, or are at risk of becoming, homeless.

During 2022-2023, we continued providing backbone support to the Service Integration program across ten priority regions in Queensland to help achieve integrated housing and support plans. We saw a significant increase in service participation from outside of the housing and homelessness sector, demonstrating the increasing breadth of services participating in the Program.

We worked closely with our colleagues in the Gold Coast Homelessness Network, Encircle, and IFYS, who auspice Care Coordination facilitators in the Gold Coast, Sunshine Coast, and Moreton Bay.

Q Shelter also auspice facilitators in Cairns, Townsville, Mackay, Brisbane, Logan, and Redlands.

Service Integration Team and Regional Representatives at Regional Forum

2022–2023 Highlights

During the year, the Service Integration program:


- Cairns Facilitated a collaboration with four other organisations (St Margaret's, Youth Link, the Women's Centre, and the Department of Housing) to continue the Young Parent Coordinated Care Project, which provides targeted housing outcomes supported by coordinated care for young women who are pregnant or parenting.
- Townsville Worked with the Housing and Homelessness Network to strengthen their capacity to identify and complete strategic, sector-owned projects.
- Mackay Worked closely with Community Accommodation Support Agency and other organisations to deliver the Community Services Expo in June 2023 and planned the Greater Whitsunday Community Housing Forum (postponed until August 2023).
- Brisbane Re-established the Queensland Hoarding and Squalor Strategy Group and developed a website where registered services can upload Hoarding and Squalor information and de-identified case studies.

- Logan Partnered with Wesley Mission, YFS, Kingston East Neighbourhood Group, and Settlement Services International to encourage Logan real estate agents to access services to support their clients whose tenancies might be at risk.
- Redlands Established ongoing Community Hubs on Russell Island, MacLeay Island, and in Capalaba, where multiple services come together in a central location to assist those experiencing homelessness.
- Collaborated with the Department of Housing to develop and implement an enhanced client management system to better support households referred into Care Coordination.
- Developed a Practice Guide to support consistent practice across Service Integration regions, while allowing flexibility when coordinating multiple service responses for placebased, local-level needs.
- Collaborated with the Department of Housing and auspice organisations to develop an Action Research Framework (launching July 2023).
- Refreshed the Program's logo, reporting templates, and resources.

Q Shelter's strength, sustainability, and future

The last 12 months has seen Q Shelter develop partnerships to deliver new funded programs including Community Housing Futures and Workforce Connect.

This has seen the Q Shelter team grow, driving the need to continue progress on IT, software, and system improvements to enable the delivery of new programs.

While we have been dedicated to advocating for housing and homelessness solutions for more than 35 years, to-date our impact has not been explicitly measured through an environmental, social, and governance (ESG) framework. We have therefore commenced a journey to develop an ESG framework to help measure our impact as a peak body. We believe that if this type of ESG framework is developed flexibly, it could also be a useful resource for other peak bodies.




